

February 4, 2020

The Regular February meeting of the Danville City Council was held on February 4, 2020, at 7:00 p.m. in the Council Chambers located on the Fourth Floor of the Municipal Building. The following Council Members were present: James B. Buckner, L.G. "Larry" Campbell Jr., Mayor Alonzo L. Jones, Dr. Gary P. Miller, Sherman M. Saunders, Fred O. Shanks, III, Adam J. Tomer, Vice Mayor J. Lee Vogler, Jr., and Madison J.R. Whittle (9).

Staff Members present were: City Manager Ken F. Larking, Deputy City Manager Earl B. Reynolds, Jr., City Attorney W. Clarke Whitfield Jr., and City Clerk Susan M. DeMasi.

Mayor Jones presided.

INVOCATION AND PLEDGE OF ALLEGIANCE

The Invocation was given by Council Member Sherman M. Saunders; the Invocation was followed by the Pledge of Allegiance to the Flag.

ANNOUNCEMENTS AND SPECIAL RECOGNITIONS

Mayor Jones read a Proclamation entitled, "National Caregivers Day" and presented it to Sophia Bolakas, Program Coordinator at Ballou Senior Recreation Center. Ms. Bolakas informed Council about the National Caregiver Day event, and discussed caregiver awareness. The Event will be on February 21, 2020 from 11:00 a.m. to 2:00 p.m. at Ballou Recreation Center. Council Members thanked Ms. Bolakas for all that she does.

COMMUNICATIONS FROM VISITORS

Mayor Jones recognized Valerie Warner, Mabin Street, Danville, VA, who spoke about the upcoming census for 2020, and explained when people will be receiving information, job opportunities and getting the word out to citizens to make sure they fill out the census form.

NEW BUSINESS

PUBLIC HEARING – CONSIDERATION OF GRANTING A SPECIAL USE PERMIT FOR WAIVER OF MINIMUM SETBACK REQUIREMENTS AT 350 MALL DRIVE

Mayor Jones opened the floor for a Public Hearing regarding Granting a Special Use Permit at 350 Mall Drive. Notice of the Public Hearing was published in the *Danville Register & Bee* on

January 21, 2020 and January 28, 2020. Mayor Jones recognized Council Member Shanks who noted he was there on behalf of Danville Mall LLC., who wished to develop an outparcel at the Mall. They require a Special Use Permit for a setback for a dumpster pad enclosed by brick, similar to the one behind Firehouse Subs, and were asking for approval of that Special Use Permit. Council Member Miller questioned what would be located there; Mr. Shanks explained it was being developed as one outparcel with two buildings. It was speculative at this point, but one could be a restaurant and the other was a dental laboratory. No one further desired to be heard and the Public Hearing was closed.

Council Member Saunders echoed Dr. Miller's statements and commended Mr. Larking and his staff for the great job they did. Mr. Saunders noted the Chair of the Committee commended Mr. Larking as well. Mr. Saunders stated to Mayor Jones, he does an excellent job as chair, and Mayor of the City. He was very respectful to visitors, he listens to them, controls the meeting very well, and thanked him for his service.

Council Member Shanks noted his agreement with Mr. Saunders on the Mayor's job as Mayor of the City. They listen to their citizens, they may not always agree with one another, but they continue to work together and get along with each. Mayor Jones thanked Dr. Miller and Council Member Saunders for representing Danville in Richmond.
