The First Regular November meeting of the Danville City Council was held on November 1, 2022, at 7:00 p.m. in the Council Chambers located on the Fourth Floor of the Municipal Building. The following Council Members were present: James B. Buckner, L.G. "Larry" Campbell Jr., Bryant Hood, Mayor Alonzo L. Jones, Barry Mayo, Dr. Gary P. Miller, Sherman M. Saunders, J. Lee Vogler, Jr., and Madison J.R. Whittle (9). *Mr. Campbell left the meeting at 7:21 p.m.*

Staff Members present were: City Manager Ken Larking, Deputy City Attorney Alan Spencer, and City Clerk Susan M. DeMasi. Deputy City Manager Earl Reynolds was absent.

Mayor Jones presided.

INVOCATION AND PLEDGE OF ALLEGIANCE

Council Member L.G. "Larry" Campbell, Jr., gave the Invocation followed by the Pledge of Allegiance.

ANNOUNCEMENTS AND SPECIAL PRESENTATIONS

Council Member Mayo thanked the citizens, vendors, employers, and resources that made the All Citizens Job Fair a success. Over 300 people came out to apply for the 1,408 jobs that were available. Mayor Jones commented that he witnessed a mother of four children get a job on the spot. Council Member Campbell stated that he was excited to see the number of people that attended. Nothing has been done of that magnitude and he wanted to commend all those who made this happen. Council Member Buckner thanked Council Member Mayo for having the foresight to pull this event together, and thanked all the companies, vendors, and everyone else who helped make this event successful.

Mayor Jones recognized Stephanie Hoer, Vice President of Mission Services, Goodwill Industries of the Valleys, who reviewed her Power Point presentation on Goodwill's reimagined future, overview of their strategic direction, the impact Goodwill was making in the Danville community, as well as Goodwill's goals for the future. Mayor Jones thanked Ms. Hoer for coming to Council and asked that she take the City Manager's card, contact him regarding services for youth that Goodwill may collaborate with the services the City was providing.

Mayor Jones recognized Lorrie Eanes, Secretary of the Danville Pittsylvania Community Services Board of Directors, who gave the annual report to Council, titled *50 Years of Unlocking Potential*. Ms. Eanes reviewed the various services provided by Danville Pittsylvania Community Services and their impact on the region. Mayor Jones thanked Ms. Eanes and Director Jim Bebeau for her presentation and for all that they do.

COMMUNICATIONS FROM VISITORS

Mayor Jones recognized Dr. Connie Fletcher, 145 Holbrook Avenue, who spoke to Council on behalf of the Danville Concert Association. She urged citizens to come to the concerts that were scheduled for this season, and left brochures for Council.

Mayor Jones recognized Felicia Hite-Venable (former captain of the G.W. Danville 1985 State Championship team) and Melbaena Hairston, who addressed Council concerning a 37-year-old issue. Ms. Venable stated that they won the Division 3 AAA State Championship for George Washington High School and were never recognized or given state championship rings. She came before Council representing the twenty members of her team asking that they look into their

receiving their reward for their accomplishment. Mayor Jones thanked them for coming out tonight and asked that she contact the City Manager so that he can coordinate with the superintendent.

Mayor Jones recognized Cynthia Jones of Jones Enterprise, and her business partner Tracey Canty, who spoke to Council regarding what they would like see done regarding the homeless community. She discussed an encounter she had with two homeless people that they helped. They have partnered with several churches and go out providing blankets, coats, and essentials for homeless individuals. Mayor Jones thanked them for what they do and asked that they contact the City Manager.

COMMUNICATIONS

Mr. Larking reminded Council that on November 12 there will be a joint meeting of the City Council and School Board at the Institute for Advanced Learning and Research. A start time has not been selected but this was a breakfast meeting and should be over by lunch. On November 29 at 5:30pm there will be a meeting with the Danville Life Saving Crew at their training center. Mayor Jones asked Council to let the City Manager know of questions or concerns they would like noted at the meetings.

There were no communications from the Deputy City Attorney or City Clerk.

Council Member Mayo thanked everyone for their participation in the job fair today. They were still in the business of helping others and wanted to encourage all citizens to get in touch with them and let them know what services they need. The shooting at the mall on Saturday was a sad event for the City; Mr. Mayo encouraged parents to listen and talk to their youth, and let them know that a weapon was not the way to go.

Vice Mayor Miller stated that the incident at the mall was tragic; a young man was dead and all his potential impacts on the future were gone. The City has to find a way to keep their young people from resorting to violence. Last week Council had a great ribbon cutting with the DeLorean Power storage project, and thanked everyone that was part of the solution to mitigate power usage increases. Dr. Miller encouraged citizens to please get out and vote on November 8.

Council Member Vogler noted his thoughts and prayers were with both families impacted by the shooting at the mall; it was truly a tragic event. One young man lost his life and another young man essentially threw his life away; it was incredibly sad. Mr. Vogler noted he wanted to make sure the city does not lose focus; this very unfortunate thing that happened did not diminish the great work that was being done by the police department and Project Imagine. Mr. Vogler noted he received a letter from a Mr. Smith who grew up in the Almagro community. The letter spoke of

the businesses, people and places of the neighborhood and within the community, the events that happened and how proud he was to have grown up there. Mr. Vogler stated that he was honored to work with each and every member of Council, and reminded everyone to go out and vote on November 8.

Council Member Whittle stated that he wanted to see the 0.04 cent per \$100 reduction on real estate taxes on the business session tonight and push it through by the next meeting. Mayor Jones noted that the business session of the meeting was over and that could be discussed in work session. Mr. Whittle stated this Council does not defund their police department, they back them up; the Council works cohesively and have come a long way. Mr. Whittle thanked the city staff, police, fire, and rescue for the great job that they do.

Council Member Buckner commented that there has been \$1,132,525,000 in new investments since 2018, with six expansions of existing companies and twenty new companies that located to Danville. That was a total of 3,922 new jobs since this Council was elected in 2018. Danville gets asked by municipalities and counties all around the state how they were doing it, and how were they able to achieve the things that they were able to achieve. The answer was very simple, teamwork. Mr. Buckner encouraged everyone to get out and vote.

Mayor Jones thanked everyone that was in attendance tonight, and everyone that gave a presentation or report for their agency. Mayor Jones noted he went to Laurel Grove for a youth summit and had an amazing time. Mayor Jones stated that they were going to run into some challenges in the city, but they cannot forget the ultimate goal. He asked citizens to help promote the positive in the community, and see how the positivity grows. He stated he was thankful for the members of Council, thanked everyone on Council personally for their support, respect, passion, and dedication to the City.
